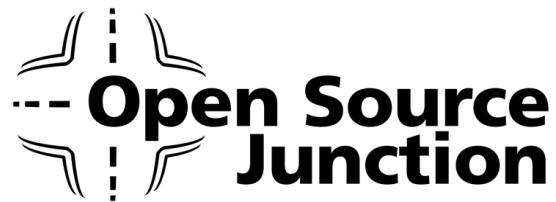

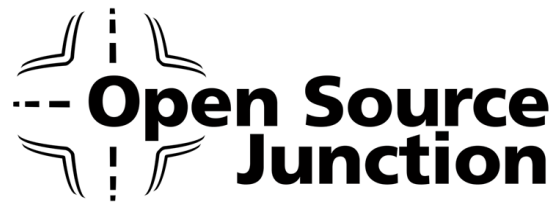

  - GPL v3 incompatible with DRM preventing modification

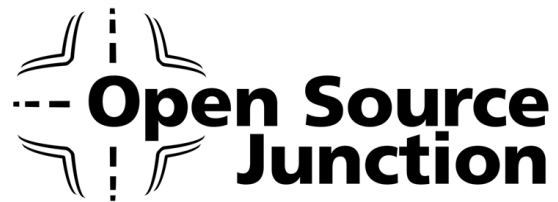

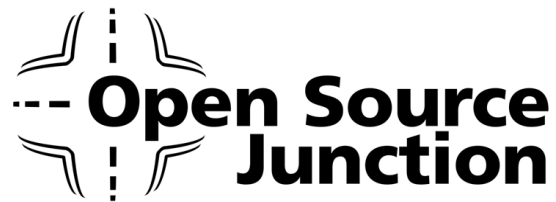

4. Blackberry SDK License Agreement specifically blocks inclusion of open source code even where developer is sole licensor

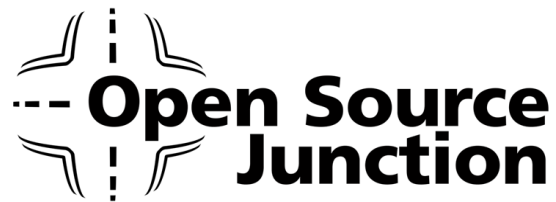

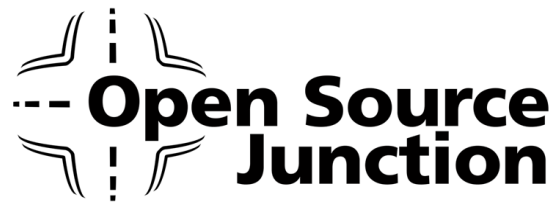

## **Are App Stores<sup>SM</sup> evil?**

1. Not by default – arguably Maemo repositories were first app stores
2. Where they are not the sole channel of distribution the problems are significantly reduced
3. Still, even where that's the case, they introduce a new form of fragmentation
4. With the model migrating to the desktop, FOSS risks being locked out unless platform controllers ease their T&Cs
